Overview

We provide a complete traffic control and management service, from site surveys and risk assessments by experienced surveyors, safe installation of the appropriate traffic control system, liaison with local authorities, site maintenance and de-installation of the chosen traffic control system

We measure our performance against defined objectives and use this to improve targets to create a culture of continual improvement. These targets are reviewed at least annually.

We ensure that all staff performing work that affects service quality are adequately LANTRA or Streetworks Unit 2 trained and competent to carry out their duties.

The management team is fully committed to the implementation of this policy statement and the continual improvements of its Quality Management System and business practices and recognises that achieving these standards is the responsibility of the entire team at TMO.

This policy is communicated to staff to ensure that they understand how their roles contribute to the achievement of TMO Traffic Highways Limited's quality objectives.

This Policy document is continually being monitored and developed and will be formally reviewed Yearly or when changes in legislation happen.

We undertake regular internal audits and have six monthly health checks completed by BSI.
