The company will seek continually to improve products, procedures and processes and is dedicated to provide the resources of manpower and equipment to reach our goals. All our employee's will receive ongoing training to enable them to meet the above requirements.

W & H Marriage and Sons Ltd is committed to both CLAS and the UK Flour Millers (Formally nabim) Standard for Intake Laboratories, and will ensure that resource allocation is sufficient for compliance.
